-As a measure of security, spectators will not be permitted to bring large bags into athletic events. Small clutch bags, with or without a handle or strap, that do not exceed 4.5" X 6.5" are acceptable.

-Students under the age of 14 must be accompanied by a supervising adult. Any student under the age of 14 who is not with a supervising adult will not be permitted in the stadium.

-No outside food, drink, or coolers are allowed in the game venue (stadium, gym, field, etc.)

STUDENT PARKING PASSES

-All vehicles parked on campus must have a valid parking pass hang tag displayed and visible every day. Students are **NOT** permitted to park on campus without a physical hang tag. STUDENT CLASS ATTENDANCE
